



OSCA Board Meeting Minutes November 18, 2025

Call to order: Kacey called the meeting to order at 7:00 pm

Acceptance of October meeting Minutes: Motion by Todd seconded by Bill

2026 Shoot Dates: Christina expressed concern about overlapping shoot dates. Citing examples of how overlapping takes away income when more than 1 shoot are scheduled the same date. Also, by doing so it could also hurt the OSCA with collection of target fees. Wondering if we can make a rule about not overlapping shoots?

Kacey stated she did send out emails to clubs with overlapping dates with mixed results. Some were able to reschedule to new dates and some did not. She also stated it is hard to enforce if a club is unwilling to reschedule.

Jake stated it's a "good problem" as the state of Ohio grows with new clubs but also understands the complications with duplicate shoots

Christina asked if there is a way that clubs can all be made aware of shoots prior to locking in dates to prevent overlaps? She states the biggest problem is not knowing that there were overlapping dates and she had to find out too late to make a change.

Sean mentions Florida has a rule that clubs must be 100 miles away in order to throw a tournament on the same date. Could Ohio do something similar?

Bill suggests sending out an email with proposed dates and then making clubs attend a meeting to discuss overlaps and hash it out that way?

Christina acknowledged nothing can be done for 2026 but would like to see changes made for 2027

Treasurers Report: Todd

- FastTrack Business Checking (**2042): \$21,158.06
- Huntington Business Premier Plus MMA (**7733): \$26,290.36
- CDs & IRAs (1): \$60,000.00

The consolidated cash balance for November 17, 2025, remains at \$47,448.42 (Beginning Balance \$47,448.42 + Credits \$0.00 - Debits \$0.00). Discussion tabled until next meeting

Todd said he will be sending payment to Prosign Studio for \$1500.00 for tent and table cover and will also send Shawn Spindel payment for the guns and ammo.

2025 Spend Down: Kacey

- Shells \$14,100 + tax

- High all-around event gun giveaways (A400s are \$1500 = \$9000) one for each class. Purchase was approved at the October meeting

- OSCA Tent: Sean Alley provided an estimate with the cost of \$1500. Purchase was approved at the September meeting.

Question asked if we are spending enough to offset the tax liability needed for this year? Discussion of ideas of what else we could/need to spend money on.

Todd expressed concern about how much money will be collected over the next 2-3 months and doesn't want to come up short

Suggestion of converting OSCA to a 501C3, most are in favor and several feel it would be a good way to spend money now

Kacey motions to move forward for making OSCA a 501C3, seconded by Jason motion passes.

2026 STATE SHOOT Shawn Spindel gave brief update on sponsorship packet and already 2 sponsors signed up. Shawn also mentioned the the sporting main trophy is looking rough and got a price to get it re-plated and engraved for about \$800 out of Philadelphia and asked if there are any other local sources. Joyce commented she knew someone in Columbus.

Shawn confirmed shells and guns are ordered and should be in by end of year.

Discussion on how to break up the shotgun shells. Shawn likes giving away 50 flats for 3 days (50 Fiocchi, 50 winchester, 50 Federal) Jake suggest 25/25 for Thursday Friday then 50 Sat and 50 Sun to award more winners.

Kacey suggest tabling the discussion and making a vote next month

OSCA TENT: Sean Alley asked for ideas on the design/artwork for the tent and accessories. Using OSCA logo and possibly photos/website/info/etc.

NEW ITEMS:

Bill Elliott suggests providing 2 boxes of shells as shooter gift next year?

Shawn asks if we are doing a raffle for a golf cart? Jake suggest maybe a shotgun instead?
