#### **2026 State Shoot:**

- Shell raffle structure, Joyce voices support of spreading out the shells for more winners, many in agreement.
- Premium shotgun raffle vs golf cart raffle – Jason suggests a premium gun vs a golf cart. Main benefit would be much easier for a winner to travel/ship vs. the golf cart. Discussion about other brands of guns, cost of guns, etc. Jake offered to give a cost for a Krieghoff, need also to look at a DT-11 from Beretta. Discussion tabled
- Shooter bag giveaway ideas – Kacey and Joyce suggest gun sleeve? Joyce guessed it was \$45/sleeve last time? Bill Elliott suggested shells last meeting, but because we are raffling off so many shells it may be redundant. Todd said he will check with Wild Hare as well to get pricing on gun sleeves.
- Tent Design – Sean will email proofs to all members

#### **Shoot Overlaps/Scheduling Issue?:**

- Kacey asked if anybody had any additional thoughts about limiting shoots to prevent overlapping?
- Jake feels it is not the job of the OSCA to set limitations on clubs. Difficult to set seniority or preference in the event of a dispute. Many members voice agreement.
- Kacey says she is still getting clubs changing/adding/modifying dates, but it is continual year-round and hard to control. Weather may change a shoot date, as well as other factors beyond our control.
- Most feel the OSCA is not meant to enforce shoot dates and prefer to leave it up to the clubs to work it out, or not with each other.

#### **NEW ITEMS:**

- Bill Elliott – not present, discussion tabled
- Todd mentions other boards have costs with annual meeting covered by the association. Could we be compensated for room/travel for the annual meeting cost or something similar? Shawn Spindel suggested compensating main entry cost for all board members? Many in agreement with this option. Discussion tabled until next meeting
- Todd mentions we will need to find new insurance provider as SIAI is no longer providing that service.
