### **2026 State Shoot:**

- **Premium shotgun raffle** – DT11 ordered? – Shawn has not ordered yet because we may be better getting a 694 or similar lower cost gun, proposed cost of \$100/ticket might be able to go \$50/ticket with a less expensive gun? Sean Alley can print tickets.
- **Motion to get the 694 by Kacey, seconded by Jake - motion passes**
- **Raffle Items** – 150 flats of Shotgun shells to raffle, need to solidify breakdown, Shotgun Raffle
- **Gun Give Aways** – A400s to be given away for the Beretta All Around (must shoot Main, 5 Stand, Prelim and Super Sporting)
- **Sponsors** – Shawn said last year sponsors should be on board to do same as last year, need to work on getting some new ones. Joyce is checking with Blackwing Shooting Center and Barepelt. Bill Elliott will talk to RE Ranger, Negrini and DA Armory. Jake said he will talk to Briley.

  - o Joyce to spoke to a vendor about padded gun sleeves (38.00/ea) several colors available

- **Trophies & Perpetual Trophy fee** – Email sent to board from Shawn with quote, said his vendor was just waiting on confirmation, everyone in agreement price is OK. **Motion by Jake second Jeff - motion passes.**
- Shawn said registration going well – need to continue promotion and drive registration
- Shawn said he received trophy back from being refurbished and looks great
- Kacey asked if we still want to do the Calcutta? Most agree if we don't lose money that it's worth doing as it adds value to the event. Discussion about allowing credit card for payment? Joyce said she will reach out to US Bank to see if they can do a mobile payment system. Shawn mentioned that it might be useful to cover purchasing raffle tickets and other items at the shoot.
